EXHIBITOR INFORMATION

ACCREDITATION

All exhibitors and vendors will receive an allocated number of accreditation wristbands, which must be worn to gain access to the venue during bump in and event days.

Accreditation must be collected from the Summernats Accreditation Centre, located at Canberra Park: Corner Federal Highway and, Old Well Station Rd, Gungahlin ACT 2912

BUMP IN + BUMP OUT

BUMP IN

All bump in access is via Gate 2 ONLY.

Date	Time
Tuesday 6th January 2026	10am – 3pm
Wednesday 7th January 2026	8am – 6pm

⚠ No bump in permitted Thu 8 Jan.

BUMP OUT

All bump out access is via Gate 1 or Gate 3 ONLY.

- Sun 11 Jan: from 3:00pm (30 mins after pavilion closure).
- Non-accredited vehicles may enter from 3:30pm.
- Must be completed by 7:00pm.
- Follow staff instructions; expect congestion.

SITE RULES

- **Site Inductions:** Mandatory for all personnel – proof of completion required before entry.
- **Speed Limit:** 20 km/h across all areas.
- **Age Restriction:** No children under 15 permitted on site.
- **PPE Requirements:** Hi-vis vest and closed-toe shoes must be worn at all times (vests available for purchase at the Summernats Site Office).
- **Plant Operation:** Only licensed operators may operate machinery.
- **Electrical Safety:** All electrical equipment must be tested and tagged before being brought onsite.
- **Unsafe Transport:** Riding in the back of utes, on running boards, forklifts, or tines is strictly prohibited.
- **Access & Exits:** Keep entrances, aisles, and emergency exits clear at all times.
- **Unloading:** Move vehicles and trailers to parking immediately after unloading.
- **Spotters:** A hi-vis spotter is required for all vehicle movements.



EXHIBITOR STANDS

INDOOR SITES

Exhibitor stands will be built prior to bump in, as per your commercial arrangement. Stands should not exceed the purchased size. All equipment, staff, infrastructure, etc. must be maintained inside the marked footprint. All aisles and emergency exits must be kept clear.

All builds and temporary structures at the event must comply with building code and event regulations.

VENUE ACCESS AND PARKING

VENUE ACCESS

The following accreditation types and entry locations are to be used gain access to the Summernats site during Bump In and Event days.

Phase	Accreditation Required	Access Gate
Bump In	Bump In Pass	Gate 2
Event Days	Event Wristband	Gate 1 & 3

NOTE: Flemington Road will be closed from 9:00am to 2:00pm each event day. Access will only be permitted outside these hours for vehicles with valid accreditation.

All vehicles require a Vehicle Access & Parking Pass (VAPP). No pass = no entry. Incorrectly parked vehicles may be towed.

ADDITIONAL PARKING

Can be purchased through the sales manager. Additional parking is available as external parking only, in P1 or P2.

STATIC DISPLAY VEHICLE

Require pre-approval and must fit within the allocated space. Static Display Vehicles must be safe and secure: no leaks, fuel tank sealed, keys removed, properly blocked/secured if on gradient or elevated.

Must display accreditation and are not permitted to cruise. A spotter in hi-vis must assist vehicle movement.

Indoor vehicles: in place by 3:00pm Tue 6 Jan and remain until 2:30pm Sun 11 Jan.

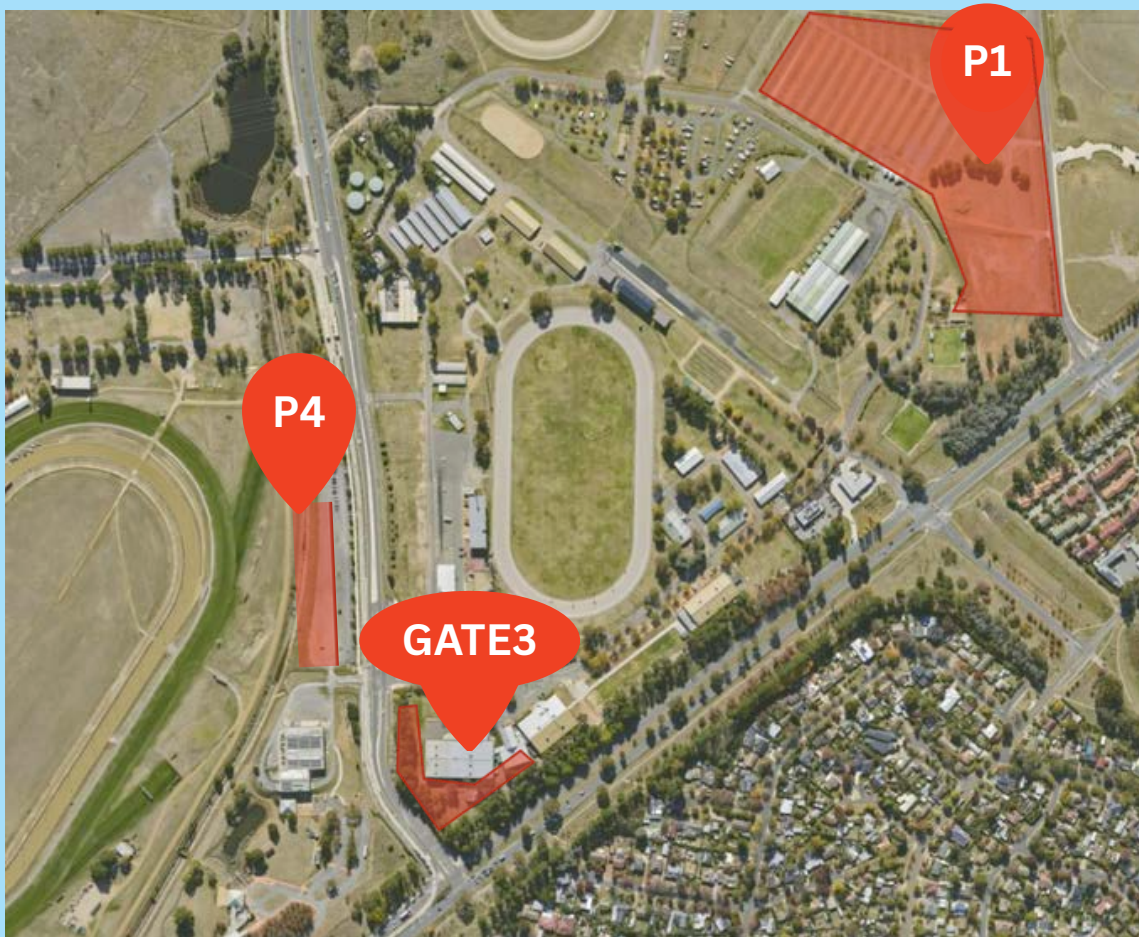


EVENT DAYS SITE ACCESS

SUPPORTING DOCUMENTS

All exhibitors must submit the following to their booking contact:

INSURANCE

- Public Liability Insurance – **minimum \$20 million**, listing the following entities as interested parties (and must not exclude Motorsport Activities);
 - Summernats 38 Pty Ltd
 - Carchella Pty Ltd
 - Exhibition Park in Canberra
- Worker's Compensation for employees/contractors.
- Comprehensive cover (including goods on display).
- Additional insurances as directed.

⚠ Without current insurance, you cannot trade at Summernats

DANGEROUS SUBSTANCE PERMIT + MSDS

All participants must complete and return the form, even if not bringing dangerous substances

FOOD VENDORS ONLY

- **Food Business Registration** (ACT, or interstate if applicable). Must be displayed onsite.
 - Not required for pre-packaged, low-risk foods (chips, confectionery).
- Gas appliances must meet Australian Standards with compliance certificates available.
- **Food Safety Supervisor Certificate** – must be displayed and a copy provided to the Food & Beverage Coordinator.



WORKPLACE HEALTH + SAFETY

Summernats is committed to providing a safe work environment for all employees, contractors and service providers. Everyone shares responsibility for safety and must report hazards.

SITE INDUCTION

Everyone, including staff, suppliers, and delivery drivers onsite during the bump in, event and bump out periods are required to complete the Summernats 38 online WHS Site Induction before arriving onsite.

EMPLOYER RESPONSIBILITY

Exhibitors are required to follow the below guidelines in consideration of workplace health and;

A safe environment for staff and visitors so far as reasonably practicable;

Safe use, handling, storage or transport of equipment and substances;

Provision of sufficient information, training, supervision, and certification

Reporting any hazards or incidents to the Summernats Partnerships Manager

LADDERS

Use of ladders will be strictly policed and standing on the top rung of the stepladders, or use of chairs to gain access to heights, are unacceptable work practices.

EMERGENCY EVACUATION

In the event of an Emergency Evacuation, ALL event patrons will follow direction from the Summernats Chief Warden and Zone Wardens.

Summernats accepts no responsibility for loss claims, financial or otherwise following an event marred or ruined by an emergency evacuation.



WORKPLACE HEALTH + SAFETY

FIRST AID

There are two dedicated First Aid centres onsite:

Med Centre 1 – outside the Rare Spares Pavilion roller door entry

Med Centre 2 – outside the Drifting Pavilion

If an accident or injury occurs, notify the nearest Summernats staff member or Security Officer immediately. They will contact the onsite medical team. All incidents must be reported to Summernats Management.

PROHIBITED ITEMS

Prohibited items as listed below are not permitted on site. Vehicle inspections will occur at all entry gates.

- Alcohol
- Animals
- Canisters of nitrous oxide or CO2
- Drones
- Fuel
- Fireworks
- Illicit Substances
- Glass
- Motorised eskies, scooters or skateboards
- Motorcycles
- Pools and spa

SECURITY

Summernats will provide security throughout the event site during bump in, event and bump out.

Exhibitors can assist to minimise risk by following these guidelines:

- **DON'T** leave valuable items unattended, leave your stand unprotected whilst open, or leave valuables in your car whilst parked in the car park.
- **DO** challenge suspicious behaviour and report it to security, ensure adequate insurances, and report damages/theft to security.



PRE / POST EVENT STORAGE

Pre or post event storage is available by application through your Summernats booking contact.

PRE EVENT STORAGE

PLEASE NOTE THE DATE IS DIFFERENT TO PREVIOUS YEARS and pre event storage is available from Thursday 18 December 2025. Deliveries prior to this date will be turned away.

Items will be stored and delivered to your site before bump in. Storage is at owner's risk.

PRE EVENT STORAGE

Overnight storage is available until 5:00pm Monday 12 January 2026.

Items must be packed and left on your site ready for transport – Summernats staff will relocate them to Building B.

Late collections may incur additional charges.



FOOD + BEVERAGE

Food and drinks may only be distributed if approved by Summernats Management (excludes official Food Vendors). If you plan to offer giveaways or samples from your stand, prior approval is required.

OFFICIAL PARTNER PRODUCTS

Only Official Partner Products may be sold:

Coca-Cola – Official Soft Drink, Water & Sports Drink Partner

- Allowed packaging: 600mL PET bottles only (no cans or 390mL PET bottles).

Flip Side – Official Energy Drink Partner

Summernats will connect exhibitors and vendors with these suppliers to arrange stock. The approved product range may be expanded (e.g., non-alcoholic, alcoholic drinks, ice).

⚠ Selling non-partner products is strictly prohibited and will result in closure of your operations at the event.



CLEANING + WASTE

Exhibitors and vendors must remove their own rubbish and waste during bump in, event, and bump out.

Recycling and general waste bins are provided – follow the Sustainability Policy. Stands must be cleaned morning and evening; keep aisles and exits clear. All tape and waste must be removed at bump out; costs apply if left behind. Liquid Waste / Sullage

Must be disposed of correctly at designated sullage points:

1. Left of Budawang Car Park
2. Tuff Street Camping
3. Torque Camping

⚠ It is Illegal to dispose in stormwater drains.

Waste oil must be in original containers and placed at designated bins. Non-compliance may result in charges or exclusion from future events.
